Before producing any responsive record(s) in its possession, SCDPS will exempt and redact "[i]nformation of a personal nature where the public disclosure thereof would constitute unreasonable invasion of personal privacy" in accordance with S.C. Code Ann. § 30-4-40 (a) (2). Also, FOIA allows a state agency to "collect reasonable fees not to exceed the actual cost of the search, retrieval, and redaction of records." Additionally, S.C. Code Ann. § 30-4-20 (c) provides that "records which by law are required to be closed to the public are not considered to be made open to the public" under the Freedom of Information Act (FOIA). Insofar as the Family Privacy Protection Act (FPPA) prohibits state agencies from disseminating certain information to the public, SCDPS will also exempt or redact any "personal identifying information" as defined by the FPPA from the record(s) it produces in response to your FOIA request.

Dear Mr. Clements:

Enclosed you will find a response to your request under the Freedom of Information Act (FOIA) for "1. All video taken by Department of Public Safety on the north side of the South Carolina State House on Wednesday, January 6 between 11 a.m. and 3 p.m., of the rally near the confederate soldier monument. Of special interest is video taken by cameras near to Gervais Street which would show the sidewalk area. 2. All still photos taken by the Department of Public Safety of the January 6 rally and individuals at the rally. 3. All report(s) of any kind written about the January 6 rally by any Department of Public Safety officials or uniformed officers who observed it."

The Department has exempted certain information from its response in accordance with the provisions of FOIA, specifically S.C. Code § 30-4-20(c). South Carolina Code § 30-4-20(c) declares that "information relating to security plans and devices proposed, adopted, installed or utilized by a public body...is required to be closed to the public and is not considered to be made open to the public under the provisions of [the Freedom of Information Act]."

Additionally, FOIA (S.C. Code § 30-4-10, et seq.) excludes from its definition of public records those records "which by law are required to be closed to the public...." Finally, S.C. Code § 23-1-240(G)(1) declares that "[d]ata recorded by a body-worn camera is not a public record subject to disclosure under the Freedom of Information Act." Accordingly, the records to be produced by the Department do not include such footage.

Included is an Incident Report written by Bureau of Protective Services Officer, Lieutenant J.A. Griffin regarding Riley D. Crawford on January 6, 2021 during the State House rally. There are no additional non-exempt records responsive to your request.
