Pursuant to the Federal Rules of Civil Procedure and the Local Civil Rules of this Court, the following schedule is established for this case.

1. Defendants will produce to all parties and the Court the administrative record in thumb drive format no later than April 14, 2023.
2. Plaintiffs will notify Defendants of any alleged record insufficiencies or omissions no later than May 30, 2023. Defendants will notify Plaintiffs of any objections to alleged record insufficiencies or omissions within seven days.
3. Plaintiffs may file a motion to complete or supplement the administrative record, if necessary, no later than June 20, 2023. Federal Defendants may file their response to such motion on or before July 5, 2023. If no motion to supplement the record is filed, the record shall be considered complete on June 20, 2023.
4. Plaintiffs may file a motion for summary judgment no later than August 4, 2023.¹

¹ This and the following dates shall be deemed void if a motion to complete or supplement the administrative record is filed and the parties will seek an amended scheduling order.

5. Defendants may file a combined motion for summary judgment and response to Plaintiffs' motion for summary judgment no later than September 18, 2023.
6. Plaintiffs may file a combined response to Defendants' motion for summary judgment and reply in support of Plaintiff's motion for summary judgment no later than October 10, 2023.
7. Defendants may file a reply in support of Defendants' motion for summary judgment no later than October 31, 2023.
8. The parties shall meet and confer in good faith on any reasonable requests to adjust deadlines set forth herein, and shall present such requests to the Court in a timely manner.
